ENGINEER/ EMT

The Position:

A person assigned to Engineer/EMT classification is trained in fire suppression, emergency medical care and is engaged in the prevention, control, and extinguishment of fires and response to emergency situations where life, property or the environment is at risk. Under the general supervision of supervisory and management staff, the Firefighter respond to fire alarms and other emergency and non-emergency calls to protect life and property; provides basic life support and medical assistance; conducts fire prevention inspections and public education programs; and may be required to work out of class on a temporary basis.

Work Schedule:

Work 24 hour shift 48/96 schedule.

Minimum Qualifications

All Training Certificates must be turned in with the application

- Candidate must be at least 18 years of age
- California Class B license with air brake and tank endorsements.
- Driver Operator 1A and 1B
- 1 Year experience as Paid Engineer or
- 2 Years' experience as Volunteer Engineer or
- 2 Years' experience Driver Operator Paid or Volunteer
- Valid auto insurance
- A current DMV printout (within Past 12 Months) upon submittal of application
- Current CPAT Certificate (within past 12 months) upon submittal of application
- Within six months after hire reside within 1 hour driving time from Jackson Valley Station #171
- One Year of continuous fire suppression, emergency medical response, and fire prevention within the last two years as a paid or volunteer firefighter

- CSFM Firefighter 1 or CSFM Firefighter 2 or Graduation from a California accredited Firefighter 1 Academy

- NWCG S-190 Introduction to Wildland Fire Behavior (online)
- NWCG L-180 Human Factors in the Wildland Fire Service (online)

Hazardous Materials Training and Certification

Certification in Hazardous Materials Fire Responder Operational (FRO) which meets California Govt. Code 8574019-22 Title 8, section 5192 and Federal OSHA Requirements 29CFR 1910.120 The certifying course is 16 hour in duration and maintaining the certification requires an annual 8 hour refresher. The certification must meet the standards established by the California Specialized Training Institute.

Incident Command System Certification

All the certifications below are required. Each of these certification can be obtained by completing free online training courses.

- ICS-100.B Introduction to Incident Command Systems ICS-100; and
- ICS-200.B ICS for Single Resources and Initial Action Incidents; and
- ICS 700.A National Incident Management System (NIMS) and
- ICS 800.B National Response Framework

Rescue Awareness Training and Certification

Certification in rescue awareness is a requirement, all courses must follow the curriculums prescribed and approved by to Office of the State Fire Marshal. The following options fulfill the rescue awareness certification requirement.

- Confined Space Rescue Awareness (7) hours or
- Confined Space Rescue Technician (40) hours.

The testing process will include a written exam, skilled based examination, oral panel and Chief's oral exam. If you are invited to test, please bring picture identification for verification purposes. After the written exam, further directions will be provided for the skills based examination. Please plan for a full day to participate in the skills based exam.

The rating scale for the examination is below:

<u>Written Examination</u>	<u>20%</u>
<u>Skills Based testing</u>	<u>60%</u>
<u>Oral Panel</u>	<u>10%</u>
<u>Chief's Oral Panel</u>	<u>10%</u>
<u>Total</u>	<u>100%</u>

The written examination administered to qualified candidates will be based on IFSTA 5th Ed, Essentials of Fire Fighting.
